Trump: Section 301 on China IPR Practice

- **USTR** conducting investigation to determine whether China is being unreasonable or discriminatory and has taking or taking actions that may be harming American intellectual property rights, innovation, or technology development.
- Initiated August 18, 2017
- September 28, 2017 Written comments & request to appear at hearing
- October 10, 2017 Public hearing
- October 20, 2017 Post hearing briefs due
- August 17, 2018 Decision due (could take longer)





Section 301

POSSIBLE ACTIONS:

- Impose duties or other import restrictions;
- Impose fees or restrictions on services;
- Restrict service-sector authorizations



Executive Order North Korea

- Issued September 21, 2017
- New Economic sanctions on any bank or company doing business with N Korea
- Treasury Dept. can target individuals, banks other companies that finance or facilitate trade with N Korea
- Freeze assets of companies that support N Korea's textile, fishing, IT and manufacturing industries
- Bars ships and aircraft that have visited N Korea from stopping in the US for 180 days



Section 232 Investigation

Secretary Ross stated report "delayed until after tax reform by Congress" and that "taxes are the single most important" factor now combined with regulatory reform.

Shares of major American Steel companies dropped after he spoke.

Presume same applies with respect to Aluminum.



Need to rebuild Texas and Florida towns after hurricanes

Section 201: Global Trade Remedy


- Solar panels
- Washing machines (vs. Samsung and LG)

Solar Panels Affirmative Decision

- September 22
- Oct 3 Remedy hearing



• 60-90 days for White House Decision/Action





Trump: Trade Negotiations - NAFTA

- Negotiations going on now through 27th
- More specific rules and proposals on the table
- Round 4 mid October in Washington DC





NAFTA Completion?

September 22 White House notified Congress of potential changes to US law (meets the 180 day TPA requirement)

March 21, 2018 would be earliest date new NAFTA could be signed

Deal would need to be reached in December (90 days before signing)

New text would have to be published in January (60 days before signing)



Trump: Trade Negotiations - KORUS

- Next consultations on October 4 in Washington DC
- Korea readying to discuss not only goods but services trade and to examine industry sectors
- Withdrawal threat more ominous for Korea

Must Pass Legislation

- Debt Ceiling Funded for 90 days
- Continuing Resolution for Government Agencies also through December 8, 2017
- Federal Aviation Administration funding extended through March 2018
- Children's Health Insurance Program funding to be extended 5 years
- National Flood Insurance Program extending until Dec 8, 2017
- Highway funding expires October 29, 2017
